Lachlan Atyeo opened the AGM at 11:10am with an Acknowledgement of Country and of people with lived experience of mental illness.


Special General Meeting Business






Motion passed unanimously Chief Executive Officer's Report

Attachment A: Special Resolution:

Item 1: Amend the Constitution to correct the errors in '5. Membership Qualifications'

To consider and, if agreed by required majority, pass the following resolution as a special resolution:

That the document titled *Constitution of Australian Capital Territory Mental Health Consumer Network Incorporated* (the Constitution) be amended as follows, recognising that the current text contains errors as marked with red stricken text for deletion and green text for replacement:

1. MEMBERSHIP QUALIFICATIONS

- 5.1 An individual is qualified to be a primary member if the individual:
 - 5.1.1. identifies as having lived experience of mental illness or psychiatric disorder, or has personally used a mental health service for their own mental health needs:
 - 5.1.2 is resident in the ACT or uses services and programs in the ACT;
 - 5.1.3 accepts the objectives of the Network; and
 - 5.1.4 has lodged an application for primary membership has been accepted for primary membership by the Board.
- 5.2 An individual is qualified to be an associate member if they:
 - 5.2.1 empathise with consumers;
 - 5.2.2 accept the objectives of the Network; and
 - 5.2.3 have been accepted for associate membership by the Board.
- 5.3 An organisation is qualified to be an associate member if they:
 - 5.3.1 accept the objectives of the Network;
 - 5.3.2 have paid the membership fee determined under clause 9; and
 - 5.3.3 have been accepted for associate membership by the Board has lodged an application for membership.
